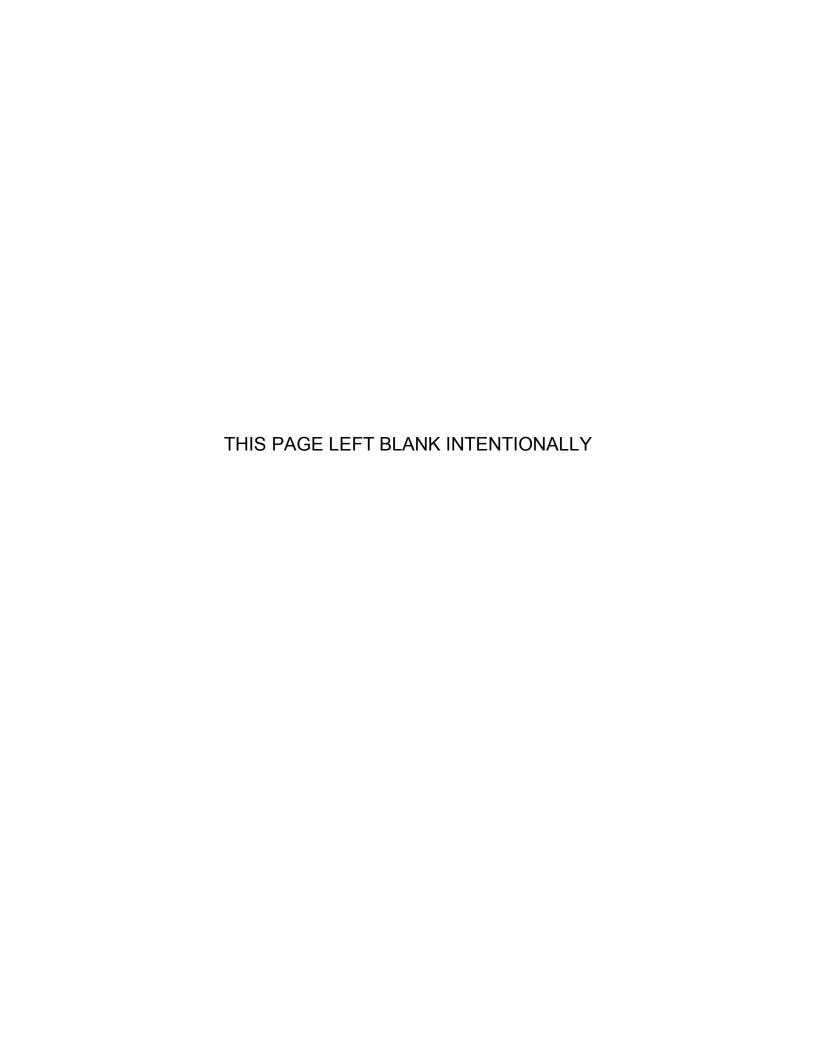



SUBJECT: Minor Housekeeping Amendment to the Fees and Charges Bylaw

#### RECOMMENDATION

THAT the Fees and Charges Bylaw 6481, 1992, Amendment Bylaw 8035, 2013 (Amendment 40) is given FIRST, SECOND, and THIRD readings.

#### REASON FOR REPORT

To introduce the Fees and Charges Bylaw 6481, 1992, Amendment Bylaw 8035, 2013 (Amendment 40) that corrects a typographical error in the Fees and Charges Bylaw that was adopted on December 9, 2013.

#### BACKGROUND

The annual amendment to the Fees and Charges Bylaw was adopted on December 9, 2013. Despite the extensive review and validation process by all departments, one typographical error was overlooked. In Schedule E "Licensing and Film Fees" the first two increments for "Areas for Storage Areas" should be from 0 to 1,860 square metres and 1,860 to 4,650 square metres instead of the currently listed 0 to 860 square metres and 860 to 4,650 square metres. The proposed bylaw amendment will correct this error.

#### Options

1. THAT the Fees and Charges Bylaw 6481, 1992, Amendment Bylaw 8035, 2013 (Amendment 40) is given FIRST, SECOND, and THIRD readings.
