#### SUBJECT: REVISED COLLECTIONS POLICY and RECOMMENDED MUSEUM DEACCESSIONS

#### RECOMMENDATION:

Pursuant to the report of the Director of the North Vancouver Museum and Archives, dated January 22, 2015, entitled "Revised Collections Policy and Recommended Museum Deaccessions":

**THAT** Council approves the NVMA Commission's Collections Policy (revised August 2014);

AND THAT Council authorizes the NVMA Commission to deaccession 66 artifacts;

**AND THAT** Council authorizes the NVMA Commission to deaccession 258 unaccessioned objects that have been found in the Museum Collection;

**AND THAT** Council authorizes the NVMA Commission to dispose of a tugboat engine (accession number 1997.51.1) that Council permitted the NVMA Commission to deaccession in 2013, but did not give permission to dispose of at that time;

**AND THAT** a process that is acceptable to the municipalities and the NVMA Commission be developed for handling all proceeds from the sale of deaccessioned materials and their use in maintaining the Museum and Archives collections and acquiring new items to augment the collections.

#### REASON FOR REPORT:

This report: 1) seeks Council's approval of a revised Collections Policy; 2) seeks permission to deaccesssion and/or dispose a total of 324 objects; 3) provides information about the Commission's rationale for deaccessioning the Harbottle tugboat engine, options for transferring and/or disposing of it and requests approval to dispose of it by public auction.

#### DISCUSSION:

#### **Collections Policy**

A Collections Policy governs everything a museum and an archives does to care for and grow its collections and make them available to the public. Through this policy document, the governing authority establishes the institution's guidelines and professional standards for collection stewardship and gives staff members the authority to implement the policy. Collection policies ensure that the institution acquires materials that advance its mission in a legal and ethical manner; that it fulfills its obligations to protect, manage, provide access to, and maintain intellectual control over its collections and their associated records; and that its collections are properly managed, housed, secured, conserved, documented, and used.

The Commission's Collections Policy was last approved by the City and the District of North Vancouver in December 1998. In 2009, using funds from a federal grant, a consultant worked with NVMA staff to re-draft a Collections Policy that would cover the collections of both the Museum and the Archives. In November 2011, the Commission approved a major revision of the Policy. Revisions to individual sections of the Policy were subsequently approved by the Commission in April 2012 (B.6.2.4) and July 2014 (B.6.9). In January 2013, Councils of both the City and the District approved a Deaccessioning Methodology (B.6.8.2) but were not asked to approve a fully revised policy document.

The attached Collections Policy (revised August 2014) incorporates all Policy changes approved by the NVMA Commission, as discussed above. The Commission now seeks District Council's approval of the attached NVMA Commission Collections Policy (revised August 2014). The Council of the City of North Vancouver approved the revised Collections Policy at its meeting on October 6, 2014.

#### Deaccessions

The NVMA Commission is the sole custodian of the cultural, archival and museum collections owned by the Corporations of the City of North Vancouver and the District of North Vancouver. The Commission's Collection Policy sets out the methodology for deaccessioning (i.e.documenting and removing) materials from the accessioned collection (section B.6.8) and for documenting and disposing of other categories of objects (section B.6.9).

Items on the attached lists have been reviewed by members of the Collections Committee (Director, Assistant Director, Archivist, Collection Manager, Collection Coordinator) and approved for deaccessioning and/or disposal by the Committee and by the NVMA Commission. No single item, in the opinion of the Director, has an estimated fair market value of more than \$1,000.

Items on these lists were reviewed and approved for deaccessioning by the NVMA Commission at three different Commission meetings:

1. At its meeting on July 17, 2014, the NVMA Commission passed the following motion:

Moved by Mr. Heywood and seconded by Ms. Downes:

THAT the North Vancouver Museum & Archives Commission approves the deaccessioning and/or disposal of all 258 objects on the list attached to the July 13, 2014 Director's Report entitled "Recommended Museum Deaccessions #2", according to the provisions of the Commission's Collection Policy, and recommends to the municipal owner of each (City and/or District of North Vancouver as appropriate) that all 258 items be deaccessioned and or/disposed of.

2. At its meeting on October 16, 2014, the NVMA Commission passed the following motion:

Mr. Watt MOVED and Mr. Evans SECONDED

THAT the North Vancouver Museum & Archives Commission approves the deaccessioning and/or disposal of all 218 objects on the three lists attached to the October 9, 2014 report entitled "Recommended Museum Deaccessions #3" according to the provisions of the Commission's Collection Policy, and recommends to the municipal owner of each (City and/or District of North Vancouver as appropriate) that all 218 items be deaccessioned and/or disposed of.

3. At its meeting on December 18, 2014, the NVMA Commission passed the following motion:

Mr. Heywood MOVED and Councillor Bell SECONDED

THAT the North Vancouver Museum & Archives Commission approves the deaccessioning and disposal of all 936 objects on the lists attached to the report dated December 15, 2014 entitled "Recommended Museum Deaccessions #4", and recommends to the municipal owner of each (the City and/or the District of North Vancouver, as appropriate) that all 936 items be deaccessioned and disposed of according to the provisions of the Commission' s Collections Policy.

[**NOTE**: At the three Commission meetings noted above, the NVMA Commission recommended that the City and/or the District of North Vancouver Council approve the deaccessioning and/or disposal of a total of 1,412 objects. Of these, the District has full or joint ownership of the 324 objects described on the attached lists of proposed deaccessions.]

According to section D.15 of the Commission's establishing Bylaws (City of North Vancouver Bylaw No. 6019) and District of North Vancouver Bylaw No. 6789), all items recommended by the NVMA Commission for deaccession will be referred to the owner (City and/or District of North Vancouver) for final approval.

#### Harbottle Engine

The NVMA has made significant attempts (outlined in the attached report) to find a public/non-profit organization to which the Harbottle Engine could be transferred. However, our efforts have been unsuccessful. We believe we have made reasonable efforts to fulfill our obligations under the gift agreement and can freely dispose of the engine with little risk to the NVMA Commission or the City or the District of North Vancouver. Accordingly we wish to proceed to sell the Engine at public auction and are seeking Council's approval for its disposal.

#### INTER-DEPARTMENTAL AND INTER-MUNICIPAL IMPLICATIONS:

Companion reports are being prepared for submission to the Mayor and Council of the City of North Vancouver containing lists of objects owned solely by the City and recommended for deaccessioning, as well as objects owned jointly by the City and the District that are recommended for deaccessioning and unaccessioned objects owned jointly by the City and the District that are recommended for disposal.

A list of all items formally deaccessioned will be provided by the Commission to the Purchasing Department of the City of North Vancouver so the items can be deleted from their Master list and the necessary adjustments, if any, can be made to insurance coverage for the collections.

# COLLECTIONS POLICY (Revised August 2014)

## COLLECTIONS POLICY HISTORY

The Commission's Collections Policy has been revised several times since the late 1990s:

- 1998 (December) Collections Policy was amended and approved by the Commission
- 2011 (November) A completely revised Collections Policy was approved by the Commission
- 2012 (April) Revised Section B. 6.2.4, "Designation of Municipal Ownership", was approved by the Commission, which also recommended approval of the complete April 2012 Collections Policy by the Councils of the City and the District of North Vancouver.
- <u>NOTE</u>: Due to timing issues that conflicted with other NVMA and municipal projects, the City and District were not asked to approve the 2012 revision of the Collections Policy.
- 2013 (January) City and District Councils approved Section B. 6.8.2, "Deaccessioning Methodology" of the Collections Policy, but they were not asked to approve the Policy as a whole.
- 2014 (July) New Section B. 6.9 "Other Categories of Objects" was approved by the Commission.
- 2014 (August) A new version of the Collections Policy (revised August 2014), incorporating the new Section B. 6.9 was prepared
- 2014 (September) A complete Collection Policy (revised August 2014) was submitted for approval to both municipalities.

#### PART A: PREAMBLE AND BACKGROUND

#### A1. PREAMBLE

The North Vancouver Museum and Archives Commission (hereafter "NVMA"; "Commission") is the sole custodian of the cultural, archival and museum collections owned by the Corporations of the City of North Vancouver and the District of North Vancouver. While retaining ultimate responsibility for the maintenance of materials held in public trust, the Councils of the City and District have agreed to delegate the management and development of the collections to the North Vancouver Museum and Archives Commission in their respective establishing Bylaws (City of North Vancouver Bylaw 6719 (1995) and District of North Vancouver Bylaw 6789 (1995)).

#### A2. INTENT OF THE POLICY

The intent of the Collections Policy is to define the nature and scope of the collections to be managed and developed, and to define the professional and institutional standards and guidelines by which materials will be acquired, documented, maintained and disposed of by the North Vancouver Museum and Archives. This Policy applies to all staff and volunteers.

#### A3. STATEMENT OF AUTHORITY

#### 3.1 Mandate of the NVMA Commission

From the North Vancouver Museum and Archives Commission Agreement (City of North Vancouver Bylaw 6719 (1995) and District of North Vancouver Bylaw 6789 (1995)):

#### The Mandate:

An understanding and appreciation of our social, cultural, artistic, political and economic history is an essential and necessary component of the fabric of our community life. The Councils of the City, and District, therefore, mandate the Commission to develop and maintain an appropriate level of museum and archives services, in accordance with commonly accepted standards, to meet the needs and interests of public bodies, corporations and organizations doing business in North Vancouver and private citizens living in the two municipalities.

#### A4. MISSION STATEMENT OF THE NVMA

We engage, strengthen and inspire our community by exploring history, connecting people and sharing ideas.

#### 4.1 Collections

In furtherance of this mission, NVMA collects, preserves, makes accessible, and interprets materials dispersed in three collections:

a) Museum Collection

This is comprised of two tiers for accessioned objects – Significant Artifacts, and Community Artifacts.

- b) <u>Archives Collection</u> Comprised of accessioned archival records
- c) <u>Education Collection</u> Comprised of unaccessioned materials for use in programs.

The Museum seeks to acquire, preserve, research, interpret and exhibit the tangible and intangible evidence of society and history. The Archives is the custodian of the community's documentary heritage, including public records created by municipal governments and private documents and photographs that record the lives and experiences of residents, businesses, and community organizations. The NVMA's collections preserve our community's collective memory and provide a foundation for the study and understanding of North Vancouver and its people.

#### 4.2 Commitment to Collection Stewardship

The Director and NVMA Commission are committed to providing a professional level of collection stewardship and will work to ensure that adequate personnel and financial resources are provided to undertake an effective collection management program, in accordance with commonly accepted standards, that will be successful in preserving the Museum's collection over the long-term to fulfil the mission of the NVMA.

#### A5. HISTORY OF THE NVMA

#### 1971

A Centennial Committee was established to form a museum and archives under the direction of William (Bill) Baker. It was housed in the historic Pacific Great Eastern (hereafter "PGE") Railway Station building, moved to Mahon Park from the foot of Lonsdale the same year.

#### 1972

On November 20, 1972, the City of North Vancouver formed a Museum and Archives Committee to administer the museum/archives building in Mahon Park and

the collection of artifacts it contained. The first meeting of the Museum and Archives Committee was held on November 30, 1972 and the name North Shore Museum and Archives was adopted in 1973.

#### 1974

The Archives sub-committee was established. From the outset, it sought professional advice and guidance regarding the development of the Archives.

#### 1976 to early 1990s

The North Shore Museum and Archives moved to the Presentation House Arts Centre, a building—shared with a theatre and a media arts gallery (Presentation House Theatre and Presentation House Gallery)—that had been built as Central School in 1902. The Museum was initially run as a traditional local history museum. It engaged in a wave of collecting to document settler life on the North Shore of Burrard Inlet through 1950. Efforts at developing a Collections Policy and documentation strategy continued through the late 1970s and 1980s.

#### Early 1990s

Bill Baker retired and a new director (Robin Inglis) was hired in 1991. He professionalized the NVMA and began a two decade long search, still ongoing, for a new facility to replace the aging museum in Presentation House. The Shipyards on North Vancouver's waterfront closed, transferring thousands of artifacts, photographs, documents and plans to the NVMA. Staff members were unable to fully process the huge volume of material transferred at that time, so both the archives and museum collections retain a significant backlog of evaluation and cataloguing work of shipyard related material.

#### 1996

The organization's scope was expanded when two separate municipalities, the City and the District of North Vancouver, agreed jointly to create and fund the North Vancouver Museum & Archives Commission. The first of a multi-year sequence of planning studies for a new museum to be located on the waterfront was undertaken. A referendum was passed by District voters authorizing the borrowing of \$1.5 million for a new heritage services building to house the archives and administration offices. (The old Lynn Valley School was later selected as the site of a new heritage services centre facility (now the Community History Centre) and the archives and offices moved there in 2006.)

#### 1997

The PGE Railway Station building was restored and moved back to its original location on the waterfront to act as a site for costumed interpretation and public walking tours of Lower Lonsdale. Through the 1990s, the Museum and Archives also focused attention on building its school, public, and outreach programming and its archival services. While the archives collection benefitted from professional management, limited attention was paid to collection management issues of the museum collection although acquisitions continued.

#### Early 2000s

Much of the organization's energy was focused on facilities projects, with little time and few resources available to manage the museum's collection. The organization created a website and provided limited online access to the museum and archives databases using, respectively, MS Access and Eloquent's "Gencat" system.

#### 2006

The archival collection and the NVMA's administrative offices moved into a new, state-of-the-art Archives facility, called the Community History Centre, while the Museum remained in Presentation House.

#### 2007

Robin Inglis retired and Nancy Kirkpatrick became the organization's third director.

#### 2008

Funding from the City of North Vancouver and the Museums Assistance Program (Department of Canadian Heritage) enabled the museum to launch a multi-year (2008 to 2012) stewardship program to overhaul all aspects of the museum's collections management policies and practices. With input from consultants, staff members, and Commissioners, the NVMA's Collections Policy was revised (between 2009 and 2011), as were all forms and practices associated with the museum collections. Key authors of the revised Collections Policy were staff members Nancy Kirkpatrick (Director), Janet Turner (Archivist), Magdalena Moore (Collections Manager), and consultants Lisa Codd and Caroline Posynick.

#### 2009

The director and a re-invigorated Museum and Archives Commission launched a year-long, consultant-led community engagement process to develop a new vision for a new museum and seek a new site.

#### 2010 to 11

The museum collection records were converted and transferred to a specialized museum database called PastPerfect. The Commission approved a new strategic plan and worked with a developer-funded consultant on a detailed Space and Cost Study for the new facility. In July 2011, the City Council rejected the idea of a museum in central Lonsdale and directed City staff to work with the Commission to find a site for a new museum on the waterfront.

#### A6. ETHICS OF COLLECTING

#### 6.1 Legal Considerations

- 6.1.1 The Museum and Archives will acquire collections in accordance with the laws of the Province of British Columbia and the Government of Canada, and international agreements between Canada and other countries.
- 6.1.2 The Museum and Archives will only acquire collections that have been legally and ethically acquired by their previous owners. Acquisitions involve a formal transfer of ownership and must be accompanied by a legal document, for example, a completed and duly signed donation form or receipt for purchase.

#### 6.2 Personal Collecting and Conflict of Interest

Personal collecting by NVMA employees and their immediate families shall not compete with the collecting activities of the Museum and Archives. Employees who collect in an area that falls within the scope of the Museum and Archives' collecting activities shall first offer significant objects for acquisition consideration to the NVMA before acquiring such objects for a personal collection. Staff and Commissioners may not use their affiliation with the NVMA to promote personal collecting activities and will conduct their personal collecting activities in an ethical manner. Commissioners and staff may not engage in activities which could reasonably be expected to lead to actual or apparent conflict of interest.

#### 6.3 Co-operation with other Institutions

The North Vancouver Museum and Archives will co-operate with other museums, archives and heritage preservation organizations in order to avoid unnecessary duplication and unseemly competition, and to promote an integrated approach for preservation and interpretation, and sharing of information.

#### A7. MONITORING, REVISING, IMPLEMENTATION & COMPLIANCE

The North Vancouver Museum Collection Policy should be periodically reviewed for relevance and compliance to ensure it is serving the purpose of managing and caring for the collection.

The Museum and Archives Commission relies on the professionalism and competence of its staff to implement this policy. With respect to the collection, as in other matters, the Commission assumes in good faith that its staff will maintain a level of performance and operation and ethics consistent with the standards established by the British Columbia Museums Association, the Archives Association of British Columbia, the Canadian Museum Association, the Association of Canadian Archivists and the International Council of Museums.

#### PART B: MUSEUM COLLECTION POLICY

#### B1. HISTORICAL BACKGROUND OF THE MUSEUM COLLECTION

The early history of the museum collection is recounted in a 1991 report by the NVMA's first director Bill Baker ("Overall Look at the Establishment of the North Shore Museum and Archives"). Collecting activity during the 1970s was haphazard. The first artifacts came from King's Mill, the City Fire Department, the shipyards, Cates Tugs, McDowell's Pharmacy, and a few private individuals. As donated

artifacts poured in, Baker stored them in his basement, in the half basement below old City Hall (now Presentation House) and in garages in different parts of the City. The museum accepted thousands of objects of material culture that documented ways of life, key industries and civic institutions during North Vancouver's early years. An important collection of First Nations objects, the Maisie Hurley Collection (formerly called the Hurley/Rogers Collection) came to the Museum in 1984. Another major collection, the Fred Amess Collection, containing several hundred works of art, was transferred from the City Library to the NVMA in 1994.

The collections quickly outgrew the available storage space and additional storage was found in City facilities, including the jail, the works yard, and the upper two floors of a bank building on Lonsdale. In the late 1980s, the museum collection was moved to a leased 8,500 sq ft warehouse, a former autobody shop and metal fabrication facility. Several large vehicles were acquired, including two City of North Vancouver fire engines and the Harbottle Dairy truck that was donated to the museum in the mid 1990s. The museum also became the custodian of a City-owned, 1908 BC Electric Railway streetcar which was partially restored by museum volunteers.

In 2008, a museum collection stewardship initiative was launched. With the assistance of consultants and a Collections Manager (hired on a four-year term), all aspects of the museum collection were reviewed and brought in line with professional norms. A "Collecting Plan (2010-2015)" was written to connect the NVMA's collecting goals to the new mission, and to the unique historical themes identified through the visioning process. The Plan articulates the central theme of the museum collection ("North Vancouver: shaped by mountains, forest, and sea"), provides structure and focus to the collection and acts as a guide for acquisitions and deaccessions.

The museum, it can be said, was 'object-focused' during its early years. The collection, preservation and display of artifacts of material culture and the dissemination of knowledge through exhibits and programs were considered its primary roles. In recent years, the museum has begun to change its relation to the collection it holds in trust for the public and is moving toward a more 'audience-centred' organizational model. This shift is reflected in the ways the museum thinks about, evaluates, and manages its collection. Going forward, museum artifacts will play a broader role in sparking dialogue, revealing social history, and connecting community members. Objects will be assessed not only in relation to their intrinsic quality, rarity, and significance, but also with regard to their ability to communicate ideas and to convey stories.

#### B2. MUSEUM STAFF ROLES AND RESPONSIBILITIES

#### 2.1 The Director

Ultimately, the responsibility for care, management, and documentation of the collection lies with the Museum Director, as delegated by the NVMA Commission. Day to day activities in caring for the physical and documentation aspects of the collection are the responsibility of the Collections Manager. (In the absence of a Collections Manager, the Curator will assume this responsibility.) He/she will employ, delegate or authorize collection management activities that follow the Collecting Plan, as well as policies and procedures that have been determined by the institution, and any relevant related policy approved by the NVMA Commission

#### 2.2 The Staff

- 2.2.1 The Collections Manager, in consultation with the Director and the NVMA Commission, is responsible for establishing policy and priorities for collections management and care, and for drafting and updating supporting procedures.
- 2.2.2 The Collections Manager will be aided in his/her collection management decisions and in the scheduling / delegation of activities by a Collections and Acquisitions Committee. The Committee will be formed of appropriate collections, curatorial, programming and Archives staff and will meet regularly to guide improvements in caring for the NVMA's accessioned collection.
- 2.2.3 All staff members have a responsibility for the preservation of the collections, including appropriate physical and intellectual care. This extends to such matters as reporting damage, or supporting collection preservation policies such as limiting food and drink in artifact areas. Staff whose work directly involves them with accessioned material, including employees who curate and manage the collection, and those who educate the community about the collection, have an additional responsibility to act in accordance with the contents of this policy and any relevant procedures which are developed from it.

#### B3. PURPOSE AND SCOPE OF THE COLLECTION

- 3.1 The collections of the museum will be maintained and developed in accordance with the Mission, Vision, and Values statements approved from time to time by the NVMA Commission and the current NVMA Collecting Plan.
- 3.2 The geographical area to be reflected in the collections of the North Vancouver Museum is deemed to consist of those lands stretching back from Burrard Inlet between the Capilano River in the west to Indian Arm in the east, forming the municipalities of the City of North Vancouver and the District of North Vancouver. Some objects not originating on the North Shore or within our geographic boundaries may be acquired in support of themes identified in the NVMA Collecting Plan.
- 3.3 The purpose of the museum collections is to preserve artifacts that provide a resource for research, exhibition, education and community building. Among the NVMA's prime responsibilities are to maximize the use of collections in programs developed and administered by the museum at its principal location(s) in North Vancouver; to support programs generated by other

organizations within the jurisdiction of the two municipalities that constitute "North Vancouver"; and to co-operate with organizations developing exhibitions or educational programs beyond the boundaries of "North Vancouver".

#### **B4. ACQUISITION POLICY**

#### 4.1 Definition of Acquisition

Acquisitions to the Museum involve artifacts acquired through a legal transfer of ownership. They are the result of bequests, exchanges, field collection, gifts, purchases, or transfers. These items may be acquired from individuals, organizations, businesses, the City or District of North Vancouver or other sources.

#### 4.2 Priorities of Collecting

The North Vancouver Museum will typically acquire artifacts that relate directly to, or may be illustrative of, the history and development of North Vancouver.

#### 4.3 Criteria of Collecting

The following criteria will assist in determining, within the context of the priorities outlined above, those artifacts to be brought into the museum collection:

- 4.3.1 Relationship to a subject area, person(s), organization, or event that is relevant to North Vancouver and the North Vancouver story and/or to the NVMA Collecting Plan's thematic framework which identifies eight key sub-themes: First Nations; Early Industry; Transportation; Outdoor recreation; Notable individuals and creative citizens; Contemporary industry; Immigration and settlement; and Community development.
- 4.3.2 Relationship to item(s) already in the museum and archives collections.
- 4.3.3 Quality; rarity; historical, artistic or cultural, scientific or technical value; representative of North Vancouver
- 4.3.4 Completeness of documentation.
- 4.3.5 Practical value of the proposed acquisition for exhibition, study or research, or for museum educational programs.
- 4.3.6 Availability of appropriate storage and / or exhibition space

- and/or Archivist. No less than once in each calendar year, the Director
- will report a list of accessions to the North Vancouver Museum and Archives Commission either through the NVMA Annual Report or as a list attached to the minutes of the Commission meeting to which it is presented.

4.4.1 Authority to purchase and to accept donations of artifacts and archival materials is delegated to the Director, who may delegate day to day responsibility for acquisitions to the Curator, Collection Manager

4.3.7 Condition and cost, including the potential costs of maintenance and

The application of these criteria to a particular acquisition is determined by the Director, working with recommendations from designated staff. At all times the staff of the Museum and Archives reserves the right to refuse artifacts or archival materials considered to be inappropriate for the collections. See section B.6.2.1 for

additional requirements for acquisition to the Museum collection.

- 4.4.2 Acquisitions that may impact significantly on the NVMA's budget will only be processed with the approval of the Commission following receipt of a report from the Director who will provide an "all inclusive" cost estimate of the proposed acquisition to the Commission.
- 4.4.3 The Director, Assistant Director, Collections Manager, Curator, and Archivist may cultivate prospective donors and actively encourage the donation of material that will enhance the holdings of the Museum and Archives.

#### B5. NVMA COLLECTION CATEGORIES

conservation.

Authority to Acquire

4.4

The NVMA's collections are made up of three main groups: archival, museum, and education collections. Transfer between these groups is at the discretion of NVMA staff, with the approval of the Director. Documentation of transfers will be maintained by the Archivist and/or the Collection Manager. Materials transferred from either accessioned collection to the education collection will first be deaccessioned.

This section of the policy deals with the management of the NVMA's museum and education collections. Policy for the management of the archival collection is provided in Part C.

#### 5.1 Museum Collection

The North Vancouver Museum's accessioned collection is held in the public trust and is made of two tiers: Significant Artifacts and Community Artifacts. Objects are assigned to a tier by the Director, who will take into consideration recommendations of the staff Acquisitions Committee. Transfer between tiers in the NVMA collection will be at the discretion of the Director, with consideration given to the recommendations of staff.

#### 5.1.1 Significant Artifacts

Artifacts in the Significant Artifact tier ("Tier One") shall have a direct and significant association with the story of North Vancouver and will be accessioned and held in the public trust. The criteria outlined in the Collecting Plan and on the Acquisition Significance worksheet will assist staff in determining the significance of an artifact. The care of the Significant Artifact tier will be in line with an expectation to maintain the physical and intellectual integrity of these artifacts for at least one hundred years. The Museum Conservation Policy applies to the Significant Artifacts collection, which shall receive the highest standard of care and priority for documentation, maintenance and conservation, and may be made available for loan to other museums providing an appropriate level of care. Handling will be by staff trained in museum artifact handling. It is expected that Significant Artifacts will make up approximately 20% of the NVMA Museum Collections. Their acquisition, accessioning, deaccessioning and disposal are governed by this policy document.

#### 5.1.2 Community Artifacts

Artifacts in the Community Artifact tier ("Tier Two") consist of objects that are not expendable, although they are not significant enough to warrant the highest level of care or documentation, and may include objects that do not have a direct association with North Vancouver but have an important role to play in programming and exhibitions. They are accessioned and held in the public trust. The care of the Community Artifacts collection will be to a standard to preserve the integrity of the object for twenty-five to fifty years. Objects in this tier may be used to enhance exhibits and programs on NVMA premises and may be loaned to public community organizations that can demonstrably provide an appropriate level of care. Handling will be provided by trained NVMA staff. Such objects are expected to make up approximately 80% of the NVMA Museum Collections. Their acquisition, accessioning, deaccessioning and disposal are governed by this policy document.

#### 5.1.3 Education Collection

The Education Collection is made up of materials that are not accessioned into the NVMA Collection or held in public trust. They may include replicas and copies, duplicates of artifacts and documents, or objects, films, and books used in programs, training or for reference. Objects in the Education Collection are replaceable and may be used in less controlled settings, such as schools and outdoors in public events, and may be handled by non-NVMA staff. Their acquisition should relate to current and anticipated projects. An inventory of this collection will be maintained. The inventory should be reviewed annually to determine whether any materials in the Education Collection should be transferred to either of the other NVMA collections. Decisions regarding acquisition and disposal of objects used in programming may be made by Education/Programming staff. Materials recommended for removal from the Education Collection, and the method of disposal, will be approved by the Director.

#### 5.2 Municipal Collections of North Vancouver

#### 5.2.1 Material Held at the NVMA

Official gifts given to the Mayors or Municipalities are included in this category of material stored at the NVMA. (Objects related to official sister city relationships or mayoral gifts may fall within this group.) Upon transfer of such objects and their documentation from the municipalities, comes the expectation of care and maintenance by the NVMA. This group of material does not include items from construction demolitions, traffic signs, or other like civic-owned objects stored at the NVMA or its facilities, but is limited to material that is created and organized by the municipalities in their official business.

An inventory of this material will be maintained. Memoranda of understanding between the NVMA and the City and District of North Vancouver will be used to clarify the material and responsibility of care and maintenance of, and access to, collections that are in NVMA's possession but for which custodial responsibility has not been transferred to NVMA.

#### 5.2.2 Material Not Held at the NVMA

The NVMA has no custodial responsibility for material from municipal collections that are held on municipal property, although NVMA staff will provide advice to the municipalities in displaying and maintaining such collections. These materials include the City of North Vancouver art collection and the Jack Loucks Native Art Collection displayed at City Hall. The NVMA will also seek to provide advice and assistance regarding the care of other municipally owned heritage assets, such as the City of North Vancouver's Streetcar #153, the stern and propeller of former victory ships built at Burrard Dry Dock, and the PGE Station.

#### B6. MUSEUM COLLECTION MANAGEMENT ACTIVITY

#### 6.1 Museum Documentation

The Museum will make and maintain a record, suitable for easy public access, of all items acquired for the collections. This section of the Collections Policy deals primarily with the management of the NVMA's museum collection.

Policy concerning the management of the archival collection is provided in Section C of this document.

Creation and maintenance of documentation of the Museum's collection is the responsibility of the Collection Manager. Documentation of each artifact will include all associated paper files and the creation of a database record which includes its unique accession number, acquisition mode, donor name and contact information, name and description of artifact, and any known history of use. The Museum uses the Chenhall terminology system to name artifacts and complies with CHIN and other professionally recognized data standards.

#### 6.1.1 Paper Files

The Museum will maintain forms including, but not limited to, collection management activities such as temporary deposit, donation, acquisition, loans in and out, deaccession, condition reports. A paper file system organized by accession number will be used to contain all documentation for each accession, including, but not limited to, all correspondence, documentation of the legal transfer of ownership, condition reports, research, and appraisals.

The Museum will use documented procedures for acquisition requirements, acquisition steps, exhibits, loans in and out, deaccession requirements and steps for deaccessioning.

#### 6.1.2 Computer Database

The Museum will maintain and update a computer database that organizes the information about the collection for ease of electronic access. The Chenhall system and other professionally recognized metadata systems should be adhered to in order to enable use of this data in shared online settings.

#### 6.2 Acquisitions

#### 6.2.1 Requirements

Material accepted into the museum collection should meet collecting criteria outlined in B.4.3. Before such material is accepted, it must be confirmed that the owner can transfer free clear title to the object, and that the object has an established and ethical provenance. The object should be in acceptable condition, and the NVMA should have the resources to adequately care for, store, and document the object. Typically, new acquisitions should not duplicate artifacts already in the collection; they should be unique objects that could not easily be borrowed from a local institution. All acquisitions should have rights conveyed/transferred to the NVMA. If a transfer is not possible, the entity that holds these rights ought to be identified, with any copyright

#### 6.2.2 Conditional Acquisitions

In normal circumstances, no acquisitions will be made whereby the conditions of acquisition may restrict the use or disposition of an object, or group of objects, in fulfilment of the goals of the institution. If restrictions are attached to an acquisition, a reasonable date for their termination will be set.

#### 6.2.3 Authentication

Identification and authentication of materials external to the institution's own collections will be given only for professional, scientific or educational purposes, and not for profit or commercial purposes.

#### 6.2.4 Designation of Municipal Ownership

Each acquisition is assigned a municipal municipal owner (City, District, or joint) as outlined in section D.14 of City of North Vancouver Bylaw 6719 (1995) and District of North Vancouver Bylaw 6789 (1995). Ownership of acquisitions to the museum collections accessioned on or before December 31, 1995 is assigned to the City. Ownership of donations and transfers from either the City or the District is assigned to the originating municipality. Ownership of acquisitions to the museum collections from sources other than the municipalities of North Vancouver, which were accessioned after December 31, 1995, is assigned jointly to both municipalities.

#### 6.3 Collections with Strong Cultural Associations

#### 6.3.1 Identifying objects of cultural significance

The NVMA will work closely with cultural groups (i.e., First Nations) to ensure that objects are properly identified through documentation and, if public viewing is acceptable, are displayed in a respectful manner when they are exhibited or are displayed online.

#### 6.3.2 Access to collections for cultural purposes

Upon written request, the NVMA may allow access to material that is culturally important to the associated cultural group. In special circumstances, these objects may be temporarily lent to the groups for cultural purposes (i.e., ceremonies) with specific written permission granted by the Director.

#### 6.3.3 Funerary and other significant right-of-passage objects

These objects will be handled and documented in accordance to the wishes of the associated cultural group and they will not be displayed without expressed written consent of the associated cultural group.

#### 6.3.4 Repatriation

Repatriation raises complex issues. Determining the route an artifact took to become part of the Museum's collection can involve incomplete, muddy or contradictory evidence, whether written or oral. In some cases, it is clear that an artifact was not acquired ethically and should be repatriated to its community. At the same time, the Museum takes seriously its role as a public repository and seeks to explore all options to work with the requesting community or individual to adhere to the spirit of repatriation request, for example, by providing special access, loans, and respectful storage and display.

#### 6.4 Access to NVMA Collections

Individuals or representatives of other institutions shall, at the discretion of an authorized member of the NVMA staff, have reasonable access to the collections of the North Vancouver Museum for research and information gathering purposes. Access to the collection and its associated materials is subject to the relevant Privacy and Freedom of Information legislation.

#### 6.4.1 Museum collection

The NVMA shall post hours for public access to the exhibition galleries.

Public access to collections in storage may be granted upon special request.

#### 6.4.2 Metadata

Information about the collection will be shared with other institutions upon request, as well as professional museum and archives associations.

Sharing the NVMA's metadata online should only be done with full knowledge of the project, the data ownership, and any proprietary and /or copyright issues that may be associated working with other institutions or organizations. All requests for metadata sharing must be approved by the Director.

#### 6.5 Rights Management

Copyright is a complex topic, and reference to the Copyright Act may need to be made on a case-by-case basis. Copyright has physical and intellectual components: it is not transferred with simple possession, as often the copyright remains with the creator of the material. It is imperative that NVMA researches and understands its material before going forward with exhibiting, reproducing, photographing or using the material in an electronic manner. This includes material with trademarked images incorporated into the work.

#### 6.5.1 At the time of donation

Wherever possible, the intellectual and exhibition rights to material acquired by the Museum should be obtained at the time of donation. A credit line for display should be determined and documented on the donation form. If the donor is also the copyright holder, and wishes to retain copyright, this should be clearly indicated on the donation form and agreed to by both the donor and the NVMA.

#### 6.6 Loans

Loans are primarily made to and from the Museum for exhibition, research or conservation purposes.

#### 6.6.1 Formal Agreement

All loans, incoming and outgoing, must be subject to a signed agreement.

#### 6.6.2 Insurance value

All incoming and outgoing loans to the Museum must be accompanied by an insurance value established by the lender (incoming) or the NVMA (outgoing) and accepted by the Director or his/her delegate.

#### 6.6.3 Documentation

All loans should have a complete set of documentation, maintained by the Collections Manager, that includes a detailed reason for loan, a description of the material, condition and/or conservation concerns, its insurance value, and the length of loan. It should include all correspondence associated with setting up the loan, plus costs and reimbursements of the loan. Periodic checks of all loan documentation will ensure all loans are up-to-date.

#### 6.6.4 Incoming

The Director, upon the recommendation of authorized staff members or guest curators, may approve temporary and short-term incoming loans. Such loans will be for research, exhibition and program use.

Incoming loans should be verified and inventoried to ensure the loan form matches the material that arrived. Loans should also be inspected upon arrival for any damage. Any immediate – or subsequent – evidence of damage should be immediately reported to the lender.

#### 6.6.5 Outgoing

#### Authority to Make Loans

No commitment to lend artifacts to another custodial institution may be made without the approval of the Director or his/her authorized delegates. Loans to a commercial concern for promotional purposes, or for the purpose of profit, are not in the spirit of the public trust placed in the NVMA. Loans should promote the mandate and goals of the NVMA and not bring embarrassment or disrepute upon NVMA or any community represented by the loaned artifacts.

The Collection Manager will evaluate material considered for loan for suitability for the travel and exhibition conditions proposed by the borrower, and a condition report will be made. Returning material also needs a condition evaluation and comparison with the outgoing condition report to ensure there was no damage during the loan period. Any signs of damage shall be documented and brought to the attention of the borrower immediately.

#### **Requirements of Borrowers**

Loans to other custodial institutions or to interested organizations will only be considered if the borrowing institution or organization can provide a level of care and security for the material(s) equal, at least, to that provided by the North Vancouver Museum and Archives; also, if there are no restrictions or covenants on the use of the materials which would be violated by the proposed loan. All lending institutions or organizations must agree to give full recognition, in any public display of loaned materials, to the North Vancouver Museum and Archives.

It is the borrower's responsibility to provide and pay for transportation of the loan to its destination and return to NVMA, as well as any incumbent costs associated with the loan such as preparation, monetary appraisal, mountmaking, packing and crating. These costs may be waived, reduced, or shared, at the Director's discretion.

#### 6.6.6 "Permanent" and Long-term Loans

The Museum and Archives will not accept in-coming "permanent" loans and will not be party to any "permanent" loan arrangement - incoming or outgoing - with any person or organization. All loans must have a termination date clearly stipulated at the time of their acceptance or release. Normally, in order to avoid custodial responsibilities and expenses and exposing North Vancouver Museum and Archives' material to undue risk over a long period of time, no loan agreement,

whether incoming or outgoing, will be for a period of more than two (2) years.

#### 6.6.7 Personal Use

There shall be no loan of any artifacts from the collections to any individual or organization for personal use or display, unless it is for accepted cultural reasons, documented by the Curator or Collections Manager and approved in writing by the Director.

#### 6.7 Risk Management

#### 6.7.1 Monetary Appraisals

The Museum and Archives will not provide monetary appraisals for any purposes external to those of the institution.

#### 6.7.2 Income tax receipts

Upon receipt of a memo and any accompanying documentation, as per City of North Vancouver requirements, the Corporation of the City of North Vancouver issues tax receipts for donations to the NVMA collections. Copies of the receipts shall be kept in the accession file.

Donors wishing to receive a charitable donation receipt for income tax purposes must substantiate the fair market value of the donated object and may be required to provide, at their cost, an independent appraisal to determine the value of their donation. If, in the opinion of the curatorial/collections staff and the Director, the donation is worth more than One Thousand Dollars (\$1,000), at least one independent appraisal should be obtained before a receipt can be issued.

#### 6.7.3 Insurance

Insurance at the NVMA is described in Attachment D of District of North Vancouver Bylaw 6789 and City of North Vancouver Bylaw 6719:

#### Insurance

- D.12 The Commission shall arrange for insurance coverage for any exposures of consequence, including
- a) at a level recommended by the Municipal Insurance Association that is acceptable to the treasurer for the City and the District, but in any case not less than \$2,000,000 per event of public liability in respect of programs operated or sponsored by the Commission, and
- b) replacement cost and property damage incurred on the physical plant and equipment, vehicles, goods, chattels, monies and securities in the care, custody and control of the Commission;

and copies of the insurance policies or binders shall be sent to the Treasurers of the City and the District.

Insurance for the museum and archives collections, as of 2010, is covered by the City of North Vancouver under the municipal insurance policy.

#### 6.7.4 Security

Collections storage and exhibitions shall be properly secured and monitored, with controlled access points to prevent unauthorized access.

Copies of donation forms should be stored at a site separate from the storage of the collection that the forms describe.

Information on the museum collections that relates to the donors and appraisal values should be protected with limited access, both the written forms and electronic records and databases.

Computer databases and spreadsheets should be backed up, with a copy of each database stored on an off-site server. A copy of each of the databases should be backed up every three months, making a separate copy to be burned to disk and stored off site.

#### 6.7.5 Privacy

All completed NVMA forms shall be stored in a locked, fireproof cabinet.

Information such as donor address and collection monetary values and appraisals, shall not be publicly visible on the NVMA database or publicly accessible files.

Credit lines for objects coming into the collection should be clarified at time of donation or loan.

#### 6.8 Deaccessions

#### 6.8.1 Definition

Deaccessioning involves the documented and approved removal of materials from the accessioned collections. As a result of changing perspectives, the goals and priorities of the institution, the acquisition of superior examples of items already in the collections, and redundancies that may occur or become apparent, it is acceptable practice and indeed desirable from time to time to deaccession materials from the collections.

#### 6.8.2 Methodology

The North Vancouver Museum and Archives will maintain rigorous and uniform procedures and documentation for the deaccession process.

- 6.8.2.1 Action regarding the disposal of artifacts will be initiated by the curatorial/collections staff, which will make recommendations to the Director. The North Vancouver Museum and Archives will not dispose of any item in its collections contrary to the terms upon which it was given or bequeathed. If practical and reasonable to do so, the institution will notify the donor if it intends to remove donated items from the collections.
- 6.8.2.2 Materials being considered for deaccession will be thoroughly investigated.
- 6.8.2.3 A record of the circumstances and conditions of the deaccession of every item will be made and retained as part of the institution's collection records.
- 6.8.2.4 The Director, at his/her discretion, may override any of the procedures set out in B.6.8.2.1 and B.6.8.2.2 if he/she determines that the material considered for deaccession is not of sufficient quality or significance and has an estimated value of less than \$1,000.
- 6.8.2.5 The Director will seek formal approval from the Museum and Archives Commission for permission to proceed with the deaccession of each item under consideration. A list of items and the reason(s) for recommending their deaccession will be provided to the Commission. This list, with any deletions deemed appropriate by the Commission, will form part of the retained record of the meeting and will be referred to the owner (City and/or District of North Vancouver) for final approval in keeping with the North Vancouver Museum and Archives Commission Agreement D.15.
- 6.8.2.6 Materials will be disposed of according to their nature and the circumstance in one of the following ways:
  - a. transfer of ownership, outright or as part of an exchange, to another public institution or organization;

 sale in the public market place in a manner that will best protect the interests and objectives of the North Vancouver Museum and Archives;

or

c. destruction.

#### 6.8.3 Limitations to Receipt of Deaccessioned items

No member of the staff of the Museum and Archives, nor any member of the Museum and Archives Commission, nor any member of the Councils of The Corporation of the City of North Vancouver and The Corporation of the District of North Vancouver, nor Employees of either the City or the District of North Vancouver who are involved in the deaccessioning and/or disposal of items may buy or receive any materials deaccessioned from the collections. The purpose of this policy is to eliminate actual or apparent conflict of interest in the deaccessioning process.

#### 6.8.4 Compliance with Laws

The deaccession process will adhere to the applicable laws of British Columbia and Canada, and to any international agreements and treaties.

#### 6.8.5 Use of Revenue

All proceeds must be deposited in a Special Purpose Fund to be used to develop and maintain the collections of the owner municipality. In the instance that the deaccessioned, sold material is owned jointly by the municipalities, the proceeds shall be shared equally between them. All monies generated through the sale of materials from the collections shall be used in one of two ways:

- to purchase other items for the cultural, archival or museum collections of the respective owner(s) for which the North Vancouver Museum and Archives will be the custodian;
- or
- to meet the cost of a suitable expenditure for the care, maintenance and preservation of the respective owner(s) collection.

#### 6.8.6 Accidental Loss/Destruction

In the event of accidental loss (theft, unaccountable disappearance) or destruction of an item in the collection, the Director will report such loss to the Museum and Archives Commission.

#### 6.8.7 Report to City and District Authorities

A list of all items formally deaccessioned or deemed to be lost shall be provided to the Purchasing Department of the City of North Vancouver so that the items can be deleted from the Master List held by that Department, and so that the necessary adjustments, if any, may be made in insurance coverage.

#### 6.8.8 Documentation

There shall be complete files kept on the deaccession process, organized first by year and then by object number. Photographs of each deaccessioned object should be attached to the paperwork, and the computer file should be retained but closed off from the main museum collection database.

#### 6.9 Other Categories of Objects

#### 6.9.1 Definitions

In addition to accessioned objects, the Museum collection contains objects that are:

- Undocumented and found in inventory;
- · Documented objects for which ownership is insecure;
- Internal Transfers between the Museum and Archival collections; and
- Unclaimed Loans and Abandoned Property.

#### 6.9.2 Undocumented and Found in Inventory Objects

Undocumented objects are similar to collection items and have been found in collections areas with no numbers, no information in their housing, nor any characteristics that might connect them to documentation.

- 6.9.2.1 The Museum will make every attempt to reconcile undocumented objects to existing documentation. Objects that are not reconciled and remain without status after all attempts to reconcile them to existing records of permanent collection and loan objects fail will be considered found in inventory (INV) objects.
- 6.9.2.2 The Museum considers undocumented and INV objects to be the property of both municipalities. Undocumented objects will be tracked and documented from the time they are found, and may be used as any object in the Museum collection is used. INV objects may be accessioned into the collection or disposed of according to approved Collection policy. The Museum Collection Manager is responsible for tracking numbers, and for bringing INV objects to the

attention of the Curator and/or Director. INV objects accessioned into the Museum collection will be given numbers in the year of accession and included in any annual report of objects.

- 6.9.2.3 If original documentation is found for an object that has been tracked or accessioned into the collection using an INV number, the object will be returned to its original status and accession number and the INV number will be retired.
- 6.9.2.4 If a claim is made on an undocumented or INV object, either accessioned into the collection or disposed of, the museum will make ad hoc decisions on accepting or challenging the claim.
- 6.9.2.5 Unclaimed objects and INV objects slated for disposal will follow the approved deaccession process as if they are Museum collection objects. In making decisions about how and where to dispose of deaccessioned unclaimed and INV objects, NVMA staff will consider the risk of future claimants coming forward, such as the uniqueness and market value of the object in question.

#### 6.9.3 Accessioned Objects Without Evidence of Secure Ownership

Secure ownership requires evidence of: 1) intention to give on the part of the source; 2) acceptance of the gift by the NVMA; and 3) physical possession.

- 6.9.3.1 Accessioned objects for which NVMA does not have evidence of an intention to give on the part of the source (the first of the three components of transfer of ownership), will be considered to be the property of NVMA.
- 6.9.3.2 The Museum will seek to uncover documentation of the ownership of its accessioned collection.
- 6.9.3.3 The deaccession and disposal of such objects will follow the approved Collections Policy

#### 6.9.4 Internal Transfer between the Museum and the Archives collections

On the Director's approval, objects that are no longer required for the Museum collection may be transferred to the Archives collection, with consideration given to the standard of care provided, and vice versa. The outgoing collection will record the object as transferred. As the Museum and Archives collections are tracked with different accession numbers, any transfers will be assigned a new accession number as per standard procedure for the receiving collection. The former accession number will be retained as part of the record of the object/material.

#### 6.9.5 Unclaimed Loans and Abandoned Property

Old loans and abandoned property are unaccessioned objects for which NVMA has:

- Possession;
- Evidence that the objects were left for a purpose other than direct acquisition approved by staff such as loan, temporary deposit for consideration for acquisition, identification, etc.;
- Evidence that more than six years has passed since the date of receipt or termination of the loan; AND
- The owner has made no contact with NVMA.
- 6.9.5.1 Such objects will be considered the property of the Museum if a good faith effort is made by the Museum to notify the owner that the Museum intends to claim ownership (which would allow the Museum to accession, loan, exhibit, transfer, and/or dispose of the object) and no reply is received in the timeframe specified in the notification, typically one month.
- 6.9.5.2 Decisions about whether to retain the object(s) in the NVMA collections or to dispose of such objects will follow the approved acquisition and deaccession and disposal policy as part of the Museum collection.

#### PART C: ARCHIVES COLLECTION POLICY

The intent of the Archives Collection Policy is to define the nature and scope of the materials to be acquired by the Archives, and to define the professional and institutional standards and procedures by which materials will be acquired, documented, preserved, made accessible to the public, and disposed of, by the Archives Department of the North Vancouver Museum and Archives.

#### C1. HISTORICAL BACKGROUND OF THE ARCHIVES

The Archives exists to identify, acquire, preserve and make accessible, material of archival and/or informational value to the City and District of North Vancouver, and to their communities as a whole.

In keeping with the requirements recognized by the archives profession for a viable archival repository, the NVMA has, from its earliest days, appointed a designated archivist to be responsible for its archival holdings. In the four years between the establishment of an Archives Sub-committee in 1974, to the first opening of the Archives to the public in 1979, committee members consulted with professional

archivists from the City of Vancouver, to prepare the archival materials in its custody for use by the public.

Four paid archivists have overseen the development and management of the current holdings: Don Bourdon (1978 to 1980, and earlier as a volunteer), June Thompson (1980 to 1994), Francis Mansbridge (1994 to 2006), and Janet Turner (2006 to present). The management of the archival holdings has kept pace with the development of archival practice in Canada.

Although the NVMA began as an operation of the City of North Vancouver, the Archives Sub-committee (est. 1974) envisaged an encompassing "North Vancouver" acquisition mandate from the beginning:

"The chairman would further propose at this time that discussion be arranged with North Vancouver District and City officials, with the objective of changing the official representation of the Committee to "North Vancouver" from its present "City of North Vancouver". Thus a greater degree of centralization of North Shore archives would be achieved. Once archives are available to be processed, additional funds will be required for more professional or semi-professional services. The additional support of the District may well be essential to the proper fulfilment of the Committee's archival responsibilities."

Annual Report of the Archives Sub-committee, 1974

This goal was fully realized in 1996, with the establishment of the North Vancouver Museum and Archives Commission. In 2006, the Archives moved from Presentation House to the new Community History Centre in Lynn Valley, thus bringing all its holdings under one roof, and providing storage capacity suitable to the acquisition mandate.

#### C2. STAFF ROLES AND RESPONSIBILITIES

#### 2.1 The Director

Ultimately, the responsibility for acquisition, care, management, and documentation of the collection lies with the Director, as delegated by the NVMA Commission. Day to day management of the archival holdings is the responsibility of the Archivist. He/she will employ, delegate or authorize collection management activities that follow the policies and procedures that have been determined by the institution.

Authority to purchase and to accept donations of artifacts and archival materials is delegated to the Director, who delegates day to day responsibility for acquisitions to the Archivist. No less than once in each calendar year, the Director will report a list of accessions to the North Vancouver Museum and Archives Commission. Each list will be attached to, and form part of, the minutes of the meeting to which it is presented.

#### 2.2 The Staff

- 2.2.1 The Archivist, in consultation with the Director and the NVMA Commission, is responsible for establishing policy and priorities for collections development, management and care, and for drafting and updating supporting procedures.
- 2.2.2 The Archivist is competent to make decisions about acquisitions on the basis of criteria detailed elsewhere in this document. He/she will consult with the Director about prospective donations that present special problems, such as making large demands on resources.
- 2.2.3 The Reference Historian is responsible for the reference and public relations functions of the archives. He/she oversees operation of the reading room, with reference to timely provision of assistance to researchers, and care and security of the collections. The Reference Historian encourages interest in, and use of, archival materials through promotions, programs, and exhibits. This position also reports on emerging trends in research topics and needs.
- 2.2.4 All staff members have a responsibility for the preservation of the collections, including appropriate physical and intellectual care. For example, reporting damage, or supporting collection preservation policies such as limiting food and drink in archival areas. Staff whose work directly involves them with the archival collections, including those who educate the community about the collection, have an additional responsibility to act in accordance with the contents of this policy and any relevant procedures which are developed from it.

# C3. PURPOSE AND SCOPE OF THE ARCHIVES COLLECTION

- 3.1 The collections of the museum and archives will be maintained and developed in accordance with the Statement of Purpose of the North Vancouver Museum and Archives approved from time to time and incorporating a Mission Statement, Goals and Objectives and themes illustrative of the 'North Vancouver Story'.
- 3.2 The purpose of the archives collections is to preserve materials that provide a resource for research of all kinds about North Vancouver. The archives' prime responsibility is to maximize the use of the collections for researchers in North Vancouver, including the general public, City and District staff, and NVMA staff. Archives staff provides research support for NVMA exhibits, programs, and educational initiatives. The Archives is also responsible for making its collections readily accessible to users outside the bounds of the geographic area.
- 3.3 The geographical area to be reflected in the collections of the North Vancouver Museum and Archives is deemed to consist of those lands stretching back from Burrard Inlet between the Capilano River in the west to Indian Arm in the east, forming the municipalities of the City of North

Vancouver and the District of North Vancouver. When a particular record creator's operations and activities were in but not confined to the North Shore, the archival records will be deemed to fall within the geographic area. A clear North Shore 'anchor' is needed to justify acquiring the material.

# C4. ACQUISITION POLICY

# 4.1 Modes of Acquisition

The Archives acquires materials in a variety of ways: by donation, bequest, copy loan, purchase, internal transfer (in the case of municipal records), or external transfer (material transferred from other repositories).

# 4.2 Sources of Acquisition

The Archives' is mandated to acquire the records of public and private organizations, families, and individuals whose lives and activities substantially took place within the geographic area (6.3 above). The principal sources of public records are the City and District of North Vancouver. Private records may be acquired from individuals, families, voluntary organizations, businesses, and quasi-governmental organizations.

# 4.3 Materials

## 4.3.1 Archival material

Archival material is all the material created, or received and accumulated, by a person, family or organization in the course of the normal conduct of affairs, and preserved because of its continuing value. These records provide evidence of the activities of their creators in carrying out their everyday affairs in the community of North Vancouver. Such material includes textual records, photographs, sound and moving images, maps, architectural plans, digital files, documentary art, and pamphlets. The 'archives' of a single record creator are unique, aggregate in nature, and treated as single entity, rather than as a collection of discrete items.

Such materials constitute the core of the Archives' holdings, and acquiring such materials is the priority of the Archives program at NVMA.

# 4.3.2 Reference Material

The term "reference material" refers to material collected or created artificially on the basis of some common characteristic (e.g., a particular subject) for the purposes of research and preservation. This material does not provide evidence of the activities of a creator in the normal conduct of affairs, and therefore lacks an archival nature. However, material of this sort may have substantial informational value. It may provide both a source of historical information for researchers and a historical context for the archival records in the holdings. This material may be books, maps, ephemera, or reference material collected by a donor, or by the Archives itself. At NVMA, such materials are treated as discrete objects, and form the basis for these important collections: NVMA Main Photograph collection; Maps and Plans collection; Sound and Moving Image collection; Pamphlet collection; Reference library.

## 4.3.3 General Criteria

The following criteria assist in determining, within the context of the priorities outlined above, those materials to be brought into the archives collections:

- a) Completeness and integrity of the archival records.
- b) Relationship to records already in the Archives, and or collections/objects held by the Museum.
- c) Quality; rarity; historical, scientific or technical value; iconic value representative of North Vancouver
- d) Informational value
- e) Completeness of identification, contextual information, and documentation.
- f) Availability of appropriate storage space and other resources.
- g) Condition and cost, including the potential costs of maintenance and conservation, restoration, and hazard to existing holdings.

The application of these criteria to a particular acquisition is determined by the Director, working with recommendations from the Archivist. At all times the staff of the Museum and Archives reserves the right to refuse materials considered to be inappropriate for the collections.

# C5. ARCHIVES COLLECTION MANAGEMENT ACTIVITIES

## 5.1 Archival Appraisal

This policy recognizes two phases of archival appraisal:

Appraisal for acquisition – assesses the archival value of potential donations, in the light of the mandate and criteria detailed above, to decide whether or not to acquire material. This appraisal occurs before documented donation occurs.

Appraisal for selection – recognizes that archival aggregates often contain material not suitable for long term preservation, such as duplicates, ephemera, and non-archival materials. Such materials are removed, and disposed of as agreed between the donor and the Archives. Such disposition is not to be confused with de-accessioning. This phase of appraisal may occur at any stage of normal processing of records. (See glossary for further discussion)

## 5.2 Acquisitions

# 5.2.1 Requirements

Before material is accepted into the archives, it must be confirmed that the donor is authorized to transfer custody of the accession to the archives. If the donor is also the record creator, that authorization is assumed to exist. If the donor acts in an official capacity for the record creator (estate executor, secretary of a voluntary group, records manager), a copy of the minutes, or other documentation, authorizing donation of materials to the archives is requested. The archives should already have the resources to adequately care for, store, and document the material.

All acquisitions should be without restrictions and, wherever possible, should explicitly include copyrights, preferably obtained at the time of donation. If a transfer of copyright is not possible, the entity that holds these rights ought to be identified, with any restrictions clearly stated and agreed to in writing by both the donor and the NVMA.

# 5.2.2 Conditional Acquisitions

In normal circumstances, no acquisitions will be made whereby the conditions of acquisition may restrict the use or disposition of that material in fulfilment of the goals of the institution. Notwithstanding the above, it is recognized that reasonable privacy restrictions may apply to some acquisitions. If such restrictions are attached to an acquisition, a reasonable date for their termination will be set. Offers of permanent loan of materials are seen to constitute an overly restrictive condition.

# 5.2.3 Copy Loans

The Archives borrows materials (usually photographs) from owners for the purposes of duplication, in order to make copies accessible to the public. A loan form documents this procedure, and the lender acknowledges by signature the transfer of copyright to the NVMA, and the return of the material. Such copies are added to the Main Photograph Collection. It is always preferable to acquire the originals, and copy loan is only done where the owner is unwilling to donate the originals.

## 5.2.4 Physical Care of Materials

## 5.3 Documentation

## 5.3.1 Accessioning

Accessioning is the process of documenting the transfer of legal and physical custody of acquisitions to the Archives, and their administrative and intellectual incorporation with the Archives collection.

Creation and maintenance of documentation is the responsibility of the Archivist.

## 5.3.2 Paper Files

The Archives will use established procedures for acquisition and accessioning. The Archives will maintain files of all forms and related documentation arising from these activities. At this time, the authoritative medium for these records is paper.

## 5.3.3 Descriptive Inventories

Archival material is made accessible through the production of various types of archival finding aids – descriptive tools produced by archivists to establish administrative and intellectual control over archival records. Basic finding aids created include accession records, descriptive inventories, shelf and container lists, indices, and specialized tools for special media. The Archives will use the Rules of Archival Description as a guide to documenting this material.

# 5.3.4 Computer Database

The Archives maintains a computer database that organizes the descriptive inventories for ease of electronic access. The Rules for Archival Description and other metadata standards of the profession will be adhered to, to enable data exchange in shared online settings. A copy of the database is backed up on a regular schedule by the City of North Vancouver IT department which hosts it.

# 5.4 Access to Archives Collections

The end purpose of all the Archives' collecting activities is to provide the maximum possible researcher access to the holdings. Researchers may be private individuals, citizens, students of all ages, paid researchers working for private concerns, and internal City, District, and NVMA users.

The Archives provides regular hours for public access to the archival collections, in a welcoming supervised reading room. The Reference Historian has particular responsibility for the reference service, and for the public relations of the Archives.

Non-archival reference materials are made available in the reading room, for researchers to use on a self-serve basis. Orientation to the repository and its systems is provided.

Archival materials are retrieved from storage by the Reference Historian and/or the Archivist, for use by researchers in the reading room. Neither reference nor archival materials are loaned to users; all materials must be used on-site, in the reading room. However, several options for copying materials are available.

The 'virtual reading room' – the NVMA website, and the Archives on-line database – provides remote access to our finding aids, and to some records such as scanned photographs and pamphlets. This 'venue' extends the reach of the Archives' public service, and its maintenance and improvement are an important aspect of the reference function.

The Archives collects statistics on use of the holdings through a registration log, records of copying requests, and Google analytic software.

## 5.4.1 Metadata

The Archives shares its descriptive metadata with other institutions through Memory BC, the union list maintained by the Archives Association of BC

## 5.4.2 Rights Management

Copyright is a complex topic, and reference to the Copyright Act may be necessary on a case-by-case basis. Copyright refers to intellectual property. It is not transferred with simple physical possession; copyright may remain with the creator of the material. It is imperative that NVMA researches and understands its material before going forward with exhibiting, reproducing, photographing or using the material in an electronic manner. The Archives is responsible to inform its researchers of copyright matters when reproductions are ordered.

## 5.4.3 Loans

Lending is done rarely, as the preferred mode of making materials available is through duplication. However, loans of certain materials, such as pamphlets where we hold more than one copy, can be permitted to the Museum, or other exhibitors who can undertake to care for the material appropriately.

Donors of materials, who wish to borrow their records for a specified short period of time, for an event or other purpose, will be given special consideration, all decisions being at the discretion of the Archivist, in consultation with the Director.

For incoming loans, see "Copy Loans" above (5.2.3)

## Insurance value

Insurance values cannot be ascribed usefully to archival materials, which have negligible market value, and are irreplaceable if lost or destroyed.

## Documentation

All loans should have documentation that includes a reason for loan, a description of the material, condition and/or conservation concerns, its insurance value if applicable, length of loan, and the borrower's signature.

# 5.5 Deaccessioning

The Archives will be guided by the more detailed provisions for deaccessioning found in the Museum's policy (Part B of this document); differences have been noted here, commonalities, not re-iterated.

## 5.5.1 Definition

Deaccessioning involves the documented and approved removal of materials from the accessioned collections. As a result of changing perspectives, alterations to the goals and priorities of the institution, and redundancies that may occur or become apparent, it is accepted practice from time to time to deaccession materials from the Archives collections.

Deaccession of archival materials would occur at the fonds (all of the records of a single record-creator) level. of accessioned reference material, at the item or accession level. Please see 5.1 – Appraisal, above.

## 5.5. 2 Methodology

The North Vancouver Museum and Archives will maintain rigorous and uniform procedures and documentation for the deaccession process.

Action regarding the disposal of material will be initiated by the Archivist, who will make recommendations to the Director. The Archives will not dispose of anything in its collections contrary to the terms upon which it was given or bequeathed. If practical and reasonable to do so, the institution will notify the donor if it intends to remove donated items from the collections. This clause applies equally to 'appraisal for selection', and deaccessioning.

## 5.5. 3 Disposition

Materials will be disposed of according to their nature and the circumstance

in one of the following ways:

a) transfer of ownership, outright or as part of an exchange, to another public institution or organization;

- b) return to donor or record-creating entity;
- sale in the public market place in a manner that will best protect the interests and objectives of the North Vancouver Museum and Archives;
- d) destruction.

# PART D: DEFINITIONS

## Accession

An accession is all the material accepted from one donor at one time into a repository's permanent collections. For the NVMA, an accession may be accepted for the Archives collections, and/or for the Museum collections.

## Accessioning

Accessioning is the process of documenting the incorporation of an acquisition into a collection held in the public trust, to gain administrative, physical, and intellectual control of the material. Accessioning involves assigning a permanent accession number, and recording detailed information about the provenance, condition, location and processing of the material. It does not include archival description or cataloguing.

# Accruals

Accruals are accessions which are additions to material already held in the Archives. Organizations which are still active often donate materials at intervals; subsequent donations are accruals.

# Acquisition

Acquisition is the legal transfer of ownership and physical custody of material to NVMA, through completion of a Donor Form, or (for City and District records) a formal letter of transfer. For the NVMA, acquisitions may be made for any of the three collections (Archives, one of two Museum collection tiers (Significant or Community), or Education).

# Appraisal, archival

Archival appraisal is the process of making decisions about whether or not to acquire materials offered to the Archives. These decisions are guided by NVMA's stated Mission, Mandate, Collecting Plan and Policy, and the Acquisition Significance Checklist.

In this context, appraisal occurs in two phases: 1) Appraisal for acquisition (does the material have long-term archival value, and does it conform to the mandate of the Archives?) 2) Appraisal for selection (among material acquired as an aggregate, are there duplicate, non-archival, or ephemeral materials which should not be retained by the Archives).

## Appraisal, monetary

Monetary appraisal is the determination of the fair market value of an object or objects, for tax, insurance, record-keeping, or sale purposes. Staff of the NVMA do not undertake formal monetary appraisals. When required, an expert appraiser is consulted.

### Collection

A collection is all of the accessioned material that is cared for by a collecting museum or archives. At NVMA, the term is used to refer to one of two groupings of accessioned material (Archives, or the Museum tiers, Significant or Community).

Additionally, in archival terminology, a collection is an artificial accumulation of discrete items gathered on the basis of some common characteristic, such as format or subject. It is used to distinguish something like a postcard collection, from a natural archival accumulation, such as the records of a community organization.

## Collection Management

Collection management is the administrative, physical and intellectual (documentation) care of material in a museum or archival collection.

## Deaccessioning

Deaccessioning is the process whereby an object or archival fonds is formally and permanently removed from an accessioned collection for reasons such as condition, lack of documentation, or weak relationship to the institution's collections mandate.

### Disposal

Disposal refers to methods of removing unaccessioned or deaccessioned material from the NVMA's physical custody: whether they should be sold, transferred into the museum or archives collections, returned to source, or destroyed. Methods must adhere to the ethical considerations in this policy

## Education Objects

These are unaccessioned objects in the Education Collection that may be similar to artifacts in the NVMA's collection, and are acquired for use in programming activities.

### Loan, Incoming

An incoming loan is material borrowed by the Museum or Archives from another institution, organization or individuals, usually for the purpose of exhibition or duplication.

## Loan, Outgoing

An outgoing loan is material loaned by the Museum or Archives to another institution, organization or individual.

## Metadata

A commonly used, if simplistic, definition is, "metadata is data about data". In the case of NVMA's collections, metadata is descriptive information, whether in textual or electronic form, about our holdings. Both the Museum and Archives use metadata standards (Chenhall, and Rules for Archival Description) to structure our

metadata, so that it will be compatible with provincial and national databanks. Technical information about our digital assets (software, resolution, file type, size, camera used, etc.) is another kind of metadata.

## Tiered Collection

A tiered collection is one with different standards for acquisition, documentation, care and handling, and conservation for material depending on qualitative judgements about that material.

# HARBOTTLE ENGINE (1997.51.1) RATIONALE FOR DEACCESSIONING and OPTIONS FOR TRANSFER or DISPOSAL September 2014

**Object No.** 1997.51.1

Date of Acquisition: 16 December 1997

Donor: Jeffery Harbottle

Location: Warehouse

Security of Title: Secure. A countersigned donation form is on file.

**Ownership:** This artifact is jointly owned by the City and the District of North Vancouver.

Object description: Direct reverse, 6-cylinder diesel engine, SN51501.

# Rationale for deaccession recommendation:

- *Significance to North Vancouver:* The object's only connection to North Vancouver is that its last owner lived in North Vancouver.
- *Storage:* The object is extremely large (~9'x20'x8') and heavy (11 tons) so occupies a large footprint in storage and requires extra support in the floor.
- *Care:* It requires ongoing maintenance, which was previously conducted by volunteers. NVMA no longer has volunteers with the expertise to maintain it.
- *Anticipated future use:* No anticipated exhibition or research use.

**Deaccession approval:** On January 14, 2013, City Council approved the NVMA Commission's request to deaccession the Harbottle engine (1997.51.1). On January 21, 2013, District Council also "authorize[d] the Commission to deaccession a tugboat engine (accession number 1997.51.1 donated by J. Harbottle) using the expedited deaccessioning process, but not to dispose of it at this time."

**Options for disposing of the Harbottle Engine:** The main disposal options for the Harbottle Engine are:

- Transfer to another public, non-profit exhibiting/collecting institution;
- Transfer to a public, non-profit marine, transport, or technology organization;
- Sale at auction (see notes under Disposal);
- Transfer to private institution or individual (see notes under Disposal); or
- Sale for scrap (see notes under Disposal)

# Concerns/issues for Disposal:

*Penalty for disposing of Canadian Cultural Property:* There is no tax penalty for disposing of material designated Canadian cultural property after 10 years of ownership. However, even after deaccessioning the artifact retains its designation as Canadian cultural property.

*Disposition*: Because the engine was designated Canadian cultural property, the Department of Canadian Heritage <u>strongly encourages</u> us to find a home for it in a Canadian public museum or like-institution, rather than with a private or non-Canadian recipient.

In addition, the counter-signed gift agreement requires us to either to return it to the donor (who is now deceased), or presumably, the donor's estate (which is not possible because a tax benefit was received by the donor), or to transfer it to a "public, non-profit institution."

However, we have been unable to find a public, non-profit institution that wishes to include the engine in its collection. And transfer or sale to a non-Canadian individual or organization, should we find one willing to acquire the Engine, would require getting permission to export Canadian cultural property (this can be a long process). Disposition of the designated cultural property, particularly in a sale to a private individual or organization, could also affect applications for cultural property or facility status in the future.

# Disposal Efforts to date:

In 2012, NVMA staff contacted the following organizations to offer to transfer the engine to their collection:

- 1. Canadian Museum of Science and Technology
- 2. Reynolds Museum of Alberta
- 3. Royal British Columbia Museum
- 4. Vancouver Maritime Museum
- 5. Vancouver Museum
- 6. Maritime Museum of British Columbia
- 7. Britannia Heritage Shipyards
- 8. British Columbia Forest Discovery Centre
- 9. Powell River Museum and Archives
- 10. Campbell River Museum and Archives
- 11. Ladysmith Maritime Society
- 12. Port Alberni Maritime Heritage Society
- 13. Richmond Museum and Archives

All of the above either declined NVMA's offer because the engine does not fit their mandate or they do not have the space or resources to care for it, or declined to respond after more details were provided at their request.

In January of 2013, representatives from the District of North Vancouver visited the NVMA collection storage warehouse to view the engine. The intent was to see if the engine could be used as a public display piece. Upon inspecting the engine, they determined it would require too great an effort to render the engine safe by removing the fluids and sealing the moving parts.

On April 4, 2014, the NVMA Collection Coordinator contacted the Atchelitz Threshermen's Association, who had previously received marine engines deaccessioned from the Vancouver Maritime Museum collection. Through their contacts, on May 2 2014, the NVMA received a call from the Campbell River Maritime Heritage Centre, expressing interest in the Harbottle engine. On June 12, 2014, Vic Anderson of the Campbell River Maritime Heritage Centre visited the NVMA storage warehouse to view the engine. Upon seeing it in person, he deemed it to be too large for their institution

A public, non-profit organization outside of Canada was not sought because the object is designated Canadian Cultural Property exporting it from Canada will require extensive paperwork. NVMA does not have the resources to organize the removal of the object from Canada.

## Discussion

NVMA believes the attempts detailed above fulfill our obligation under the terms of the donation agreement to transfer the object to another public, non-profit institution. NVMA staff have contacted the Department of Canadian Heritage, the agency that designates Canadian Cultural Property, and staff of that Department have indicated that we have more than demonstrated an attempt to keep the object in the public realm, and they are satisfied with our attempts. They have indicated that deaccessioning and disposal of the object will not impact future applications for Canadian Cultural Property status.

NVMA discussed the disposal of the engine with the Purchasing Managers for both the City and District of North Vancouver. Both indicated that it might be useful to another municipality as a back-up generator (in 2014, NVMA staff confirmed that the engine still turns over) and could possibly be sold at auction for this purpose.

We believe we have exhausted our options to transfer the engine to another public/non-profit collecting and exhibiting institution and to a public non-profit marine/transport/technology organization. We believe we have made a reasonable effort to fulfill our obligations under the gift agreement and can freely continue with disposal with little risk to the NVMA Commission and the municipalities of North Vancouver. We would like to proceed to sell the Engine at public auction.

## Recommendation

NVMA staff recommend that District Council approve disposal of the Harbottle Engine by public auction. We ask that Council authorize staff of the District's Purchasing Department to assist, if needed, in disposing of the engine.
