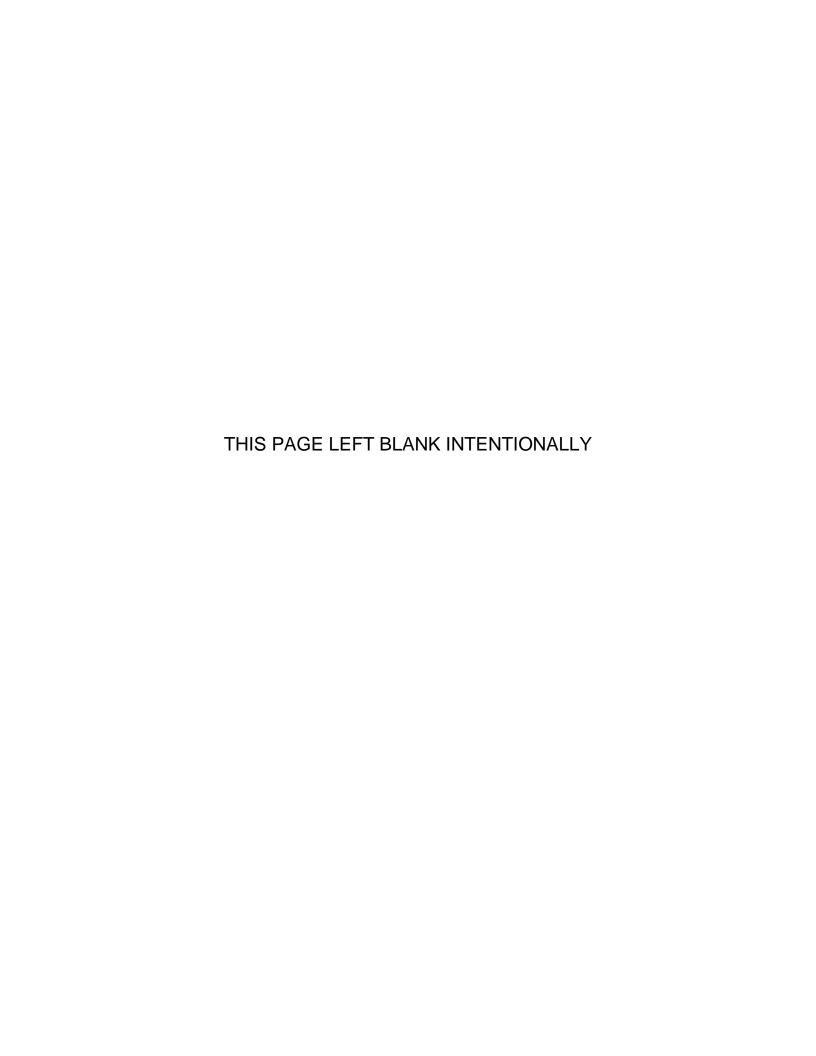

  - (c) there is an error or omission respecting the taxable area or the taxable frontage of a parcel;
