- Spoke regarding the expected removal of the Coast Guard Base in Kitsilano;

- · Requested that a meeting be arranged with staff to discuss RCMP issues; and,
- Suggested that staff look at the Lloyd Avenue site for the possible relocation of the indoor tennis courts.

2.5. Ms. Tracey Cochrane, 1000 Block West 22nd Street:

- Spoke as the owner of the Pemberton Heights Corner Store;
- Stated that because of the limited market, the corner store is struggling;
- Urged Council to support the zoning bylaw text amendment which will allow customers to enjoy an alcoholic beverage; and,
- Commented that the support from the local community is both overwhelming and encouraging.

2.6. Mr. Paul Winstanley, 1600 Block McNair Boulevard:

- Spoke as the head coach of the Handsworth field hockey senior team;
- Expressed concern that if William Griffin is replaced with a soccer based turf they will no longer be able to use the field;
- Commented that a 40mm turf allows for sufficient ball roll and reduced bounce which can become a safety concern; and,
- Requested that the field be replaced with a multi-sport turf so that all groups can use the field.

• Spoke in support of the Pemberton Heights Corner Store zoning bylaw text amendment.

2.8. Ms. Mary Lindsay, 4300 Block Carolynn Drive:

- Commented that field hockey players will be forced to play in other municipalities; and,
