Bylaw 7934: Proposed Updates to Development Permit Areas Community Plan

(Schedule B) of the District Official

Purpose of Bylaw:

Bylaw 7934 proposes to add Schedule B, Development Permit Areas, to the District Official Community Plan Bylaw 7900 and repeal Schedule B, Development Permit Areas, of the old District Official Community Plan Bylaw 6300. The new Schedule B incorporates improved technical information and provides more specific and consistent guidance for development.

1. OPENING BY THE MAYOR

Mayor Walton welcomed everyone and advised that the purpose of the Public Hearing was to receive input from the community and staff on the proposed Rezoning Bylaw as outlined in the Notice of Public Hearing.

Ms. Natasha Letchford, Deputy Municipal Clerk, introduced the proposed bylaws and advised that all those who consider that their property may be affected are welcome to speak.

Staff advised that legal tools are limited to reduce noise pollution from outside sources such as railway cars and freeways. Staff noted that when developing in an area where there are noise issues, it is important to incorporate significant barriers to address noise issues within the building structure.
