
# DISTRICT OF NORTH VANCOUVER PUBLIC HEARING

#### Bylaw 7954 The District of North Vancouver Rezoning Bylaw 1285

Purpose: Bylaw 7954 will permit a liquor store on what is currently the Lynnwood Inn and Hotel parking lot.

> The parking lot property is currently zoned Commercial which permits liquor store use on lots that are over 8,500m<sup>2</sup> in size. The proposed bylaw would allow this site to have a liquor store despite the site

being smaller than required.

#### 1. **OPENING BY THE MAYOR**

Acting Mayor Bassam welcomed everyone and advised that the purpose of the Public Hearing is to receive input from the community on the proposed amendments to the Zoning Bylaw as outlined in the notice of Public Hearing. He also informed those in attendance of the procedural rules that will be followed.

#### 3. PRESENTATION BY STAFF

Presentation: Tamsin Guppy, Planner

Ms. Tamsin Guppy, Planner, presented the proposal for a text amendment to the C2 Zone to permit a liquor store to be located on this site in accordance with the Official Community Plan. The owners of the Lynnwood Inn and Hotel are proposing to rebuild the liquor store on the Lynnwood's parking lot which is a separate property on the north side of Barrow Street. The parking lot property is zoned Commercial which permits liquor stores, but only when they are on large sites.
