Presentation: Nicole Deveaux, General Manager – Finance & Technology

Ms. Nicole Deveaux, General Manager – Finance & Technology, presented the 2014 Budget Plan. Ms. Deveaux highlighted the:

- Context of the 2014 budget planning process;
- Proposed tax rate increase of 2.5%;
- Analysis of the budget drivers;
- Surplus utilization; and,
- Capital Budget.

Ms. Deveaux advised that the sustainment capital 1% policy targets will reach \$13 million in 2015; staff propose to continue with the policy until 2018 to reach the reserve targets.

Mr. Stuart advised that 40% of the capital expenditure in 2014 is attributable to the Philips Overpass project. The District has leveraged private, Federal, and Provincial funding to achieve this project.
