**3. REPORTS FROM COUNCIL OR STAFF**

### 3.1. Developing a Connected Network of Bicycle Facilities

File No. 16.8450.40/004.000

Mr. Steve Ono, Manager – Engineering Services, reported that the purpose of the Workshop is to review and prioritize possible bicycle network routes.

Mr. Ono noted that new terminology has been introduced since the North Vancouver Bicycle Master Plan was updated in 2012, including All-Ages-and-Abilities (AAA) and protected bicycle routes. It was noted that the Bicycle Master Plan covers both the City and District of North Vancouver.

Mr. Ono provided an update on recent additions to the bicycle network, including the western section of the Pacific Spirit Trail and the installation of bicycle facilities during the construction of the new Keith Road Bridge and seismic retrofit of the Mt. Seymour Parkway Bridge. It was noted that the geography of the District presents design and cost challenges in developing a bicycle network.

Ms. Shazeen Tejani, Transportation Planning Technologist, reported that District residents fall into one of three groups:

- Regular cyclists who make at least one trip per week and are generally comfortable riding on the road: 25%
- Not interested in riding a bicycle: 34%
- Interested in riding, but concerned about sharing the road with moving vehicles: 41%

The largest group is made up of those who might cycle more if there were appropriate facilities. This group's interests include physical separation from vehicle traffic, traffic calming measures, coordinated signals, clear markings at conflict zones and being able to cross intersections safely. While working toward providing safe and comfortable AAA bicycle facilities for this group and regular cyclists, the District may also consider interim measures. It was noted that Transportation Plan goals to shift modes from vehicle use to other modes are not currently being met.

Following Council's direction, staff has developed three possible priority routes to connect Town Centres, which would require \$15-20M to be allocated in the Long-Term Financial Plan. The actual cost will be dependent on the design of the routes and the type of facilities installed. It was noted that grant funds may be available to the District to build bicycle facilities.

Ms. Tejani reviewed the process for building the AAA bicycle network, noting that residents and stakeholders will be consulted to ensure transparency and accountability.

In response to a question from Council, Mr. Ono provided details of the different priority routes identified in the October report:

- Connecting Lynn Creek and Lions Gate Town Centres, including use of the existing Pacific Spirit Trail in the City of North Vancouver;
- Connecting Lynn Creek and Maplewood Town Centres as part of the eastern section of the Pacific Spirit Trail; and,



- Connecting Lynn Valley and Lynn Creek including use of the proposed Casano Drive overpass to Loutet Park, located in the City of North Vancouver, which would allow cyclists to cross the highway.

Council discussion ensued and the following comments and concerns were noted:

- Requested information on the timeline for connecting other Town Centres and Village Centres;
- Suggested accelerating the development of network connections;
- Expressed concern regarding the use of urban trails due to conflicts between pedestrians and cyclists;
- Queried the current usage of existing trails;
- Commented on the need for bicycle access to the Seymour area and suggested Mount Seymour Parkway would be a safer route than Dollarton Highway;
- Expressed support for AAA facilities and keeping cyclists separate from vehicle traffic;
- Noted commuter and recreational cyclists use different routes;
- Suggested reducing parking requirements for multifamily developments near transit hubs;
- Commented on the impact of rideshare on transportation modes and congestion;
- Noted small differences in transportation modes have a large impact on congestion;
- Commented on health and safety benefits of reducing vehicle use and increasing active transportation;
- Commented on public engagement opportunities; and,
- Requested more detailed route maps showing elevations and steep sections.

In response to a question from Council regarding cycling commuters using the Ironworkers Memorial Bridge, staff advised that the District is working with the Ministry of Transportation and Infrastructure (MOTI) to incorporate bicycling improvements in the construction of the new interchange at Mountain Highway and Fern Street-Lillooet Road. Staff further advised that two new crossings over Lynn Creek are planned, which will provide an opportunity for a separated pathway on the north side of the highway.

In response to a question from Council regarding cost variables, staff advised that design decisions such as whether to acquire rights of way or give up road space on arterials for separations, as well as the type of facilities and the need for traffic calming on certain types of roads would determine actual costs.

THAT staff is directed to further develop plans and cost estimates for the priority connected network of bicycle facilities to link key destinations using 'All-Ages-and-Abilities' (protected bicycle facilities) design traits and emerging tools to advance safety and comfort as outlined in the March 27, 2017 joint report of the Transportation Planner and the Transportation Planning Technologist entitled Developing a Connected Network of Bicycle Facilities;

AND THAT staff is directed to develop and implement a bicycle monitoring program of the priority routes;

AND THAT the priority routes are referred to the long-term financial plan process for funding.

- Commented on connections between the City and District of North Vancouver; and,
- Suggested adding street names to the proposed route map.

**4.4. Mr. Corrie Kost, 2800 Block Colwood Drive:**

- Requested a cost-benefit analysis of the bicycle network;
- Commented on the aging North Shore population; and,
- Recommended the development of an app to help cyclists and pedestrians plan routes.

**4.5. Mr. Paul Lewis, District Resident:**

- Thanked Council for their support of cycling network improvements.
