

Bylaw 8468

A bylaw to amend Solid Waste Removal Bylaw 7631, 2007

The Council for The Corporation of the District of North Vancouver enacts as follows:

Citation

1. This bylaw may be cited as "Solid Waste Removal Bylaw 7631, 2007 Amendment Bylaw 8468, 2020 (Amendment 18)".

Amendments

- 2. Solid Waste Removal Bylaw 7631, 2007 is amended by:
 - (a) adding the following as a new Part IX and re-numbering the remainder of the bylaw accordingly:

PART IX - Wildlife Attractant Management

- 48. A person must not store any *attractant* outdoors except where such *attractant* is secured in:
 - (a) a wildlife resistant container; or
 - (b) a container that is located within a wildlife resistant enclosure.

This section 48 does not apply to refuse put out for collection in *solid waste* containers on the collection day and put out in accordance with all applicable requirements of this bylaw.

- 49. Every *owner* and *occupant* of a residential dwelling must ensure that in respect of such *property*:
 - (a) any fruit that has fallen from a tree is removed from the ground within 3 days and, if stored outdoors, stored in a *wildlife resistant container*;
 - (b) any bird feeder containing bird feed, suet, nectar or other bird food is suspended on a cable or other device in such a manner that it is inaccessible to wildlife, except birds, and that the area below such feeder is kept free of accumulations of seeds and attractants;

- (c) any composting activity is carried out and any composting device or equipment is maintained in such a manner so as not to attract wildlife;
- (d) barbecue or other outdoor cooking equipment and tools that remain outdoors are kept clean and free of residual food or grease;
- (e) any refrigerator, freezer, storage container or similar appliance or apparatus located outdoors that contains *attractants* is located and locked so as to be inaccessible to *wildlife*;
- (f) any attractants are stored so as to be inaccessible to wildlife;
- (g) bees and beehives are kept in such a manner so as to not attract wildlife.
- (b) deleting sections 26 and 27 and substituting the following:
 - 26. Solid waste containers will be supplied by the District and remain the property of the District and must remain with the property to which they were issued even when the owner or occupant moves and must be marked with the address of the property thereon.
 - 27. Where a solid waste container is stored outside of a building, the owner or occupant of the property must ensure that the lid of the solid waste container remains closed and locked at all times, except when the container is put out for collection on a collection day.
- (c) adding the following definitions to section 2 in alphabetical order:
 - (i) "Attractant" means any substance or material, with or without an odour, which could reasonably be expected to attract wildlife or does attract wildlife and includes, without limitation, household waste, food products (whether intended for humans, animals, or birds), diapers, grease, oil, antifreeze, paint and petroleum products;
 - (ii) "Food waste" includes fruit and vegetables, meat, fish, bones, seafood shells, coffee grounds and filters, tea bags and leaves, eggshells, dairy, coffee, tea, pasta, rice, baked goods, food-soiled paper and any other such material identified and communicated by the *District* to the residents as suitable for collection and composting as food waste
 - (iii) "Organics" means food waste and yard trimmings;

- (iv) "Organics container" means a container owned and supplied by the District to contain food waste and yard trimmings to be put out for collection under the Curbside Collection Service;
- (v) "Recycling container" means a container approved by the District or the collector to store recyclable material;
- (vi) "Wildlife resistant container" means a solid waste container or other refuse container that is designed to discourage and prevent access by wildlife whose material and construction is of sufficient strength and design to prevent access by wildlife during storage and which has a sturdy cover capable of being completely closed and secured with a latching device (or an alternative acceptable to the General Manager of Engineering). For use other than residential, such container must be made of metal and be self-latching;
- (d) deleting the definitions of *garbage*, *solid waste container* and *yard trimmings* in section 2 and substituting with the following:
 - (i) "Garbage" means rubbish, non-recyclable materials, waste, litter, refuse or other discarded materials, excluding hazardous waste, organics, recyclable material or other materials communicated by the District to the residents as not acceptable for collection;
 - (ii) "Solid waste container" means a garbage container or organics container;
 - (iii) "Yard trimmings" includes weeds, leaves, grass and tree, plant or shrubbery cuttings less than 7.5 cm in diameter and less than one meter in length.
- (e) adding the following offences to the end of Schedule B:

Citation

1. This bylaw may be cited as "Bylaw Notice Enforcement Bylaw 7458, 2004 Amendment Bylaw 8469, 2020 (Amendment 55)".

Amendments

- 2. Bylaw Notice Enforcement Bylaw 7458, 2004 is amended by:
 - a. deleting subsection 8(b) and replacing with the following:
 - (b) The following are designated classes of persons that may be appointed as screening officers:

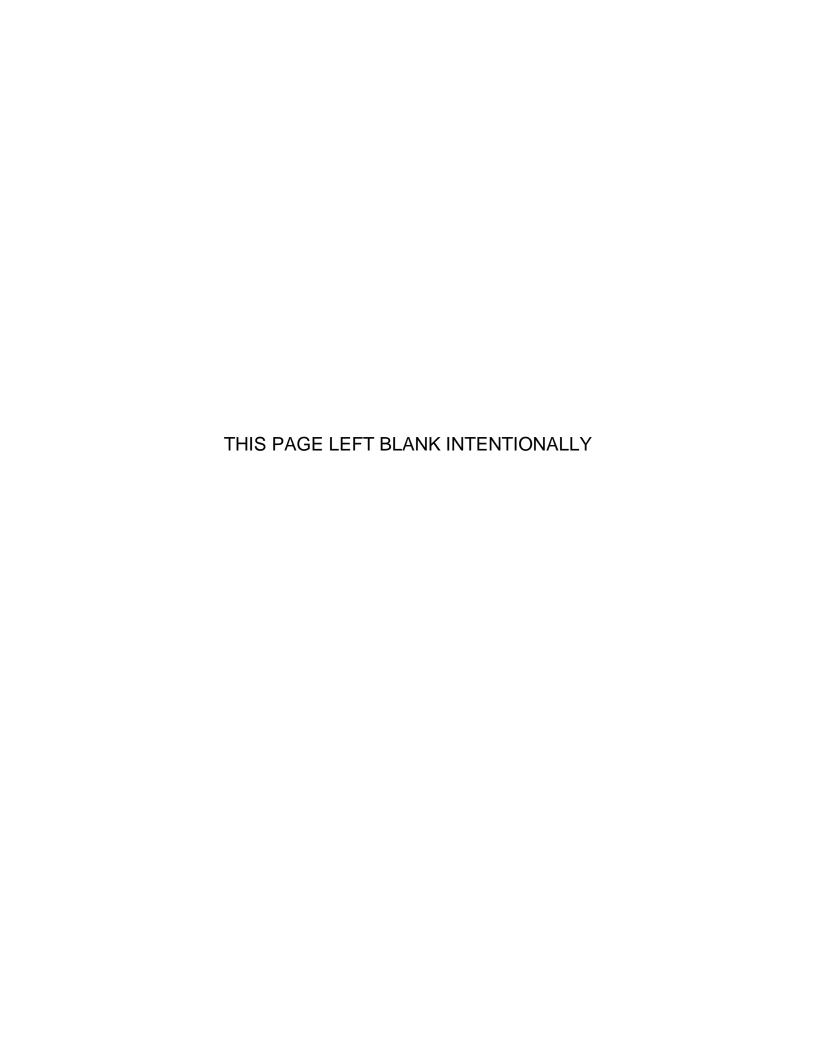

SUBJECT: Solid Waste Removal Bylaw 7631, 2007 Amendment Bylaw 8468, 2020

RECOMMENDATION:

THAT "Solid Waste Removal Bylaw 7631, 2007 Amendment Bylaw 8468, 2020 (Amendment 18)" is given FIRST, SECOND and THIRD Readings;

AND THAT "Bylaw Notice Enforcement Bylaw 7458, 2004 Amendment Bylaw 8469, 2020 (Amendment 55)" is given FIRST, SECOND, and THIRD Readings.

REASON FOR REPORT:

During the October 5, 2020 regular meeting, Council directed staff to expedite the issue of managing black bear and wildlife attractants and propose an amendment to the Solid Waste Removal Bylaw 7631 and the Bylaw Notice Enforcement Bylaw 7458.

SUMMARY:

The Solid Waste Removal Bylaw amendment proposes the following:

- 1. Changes to the fine structure for setting carts out the night before collection.
 - \$100 for first offenses and \$500 for subsequent offense(s)
 - Expresses the prohibition as place solid waste container out for collection outside times permitted, for clarification purposes
 - o Requires carts to be removed from the curb by 9:00pm on collection day
- 2. Added a new Wildlife Attractant Management section with requirements for managing attractants and corresponding fines for violations. There are fines for:
 - o Store attractants outdoors not in a wildlife resistant container or enclosure
 - o Fail to remove fruit
 - o Fail to manage bird feeder, compost, bees
 - o Fail to keep barbecue clean
 - Fail to make appliance inaccessible to wildlife
- 3. Added Sections 26 and 27 to confirm that solid waste containers:
 - o are the property of the District,
 - o must remain at a given property,

- o and must remain locked on the property until the morning of collection day.
- 4. Includes new definitions to support the wildlife attractant management sections.
 - o Attractant, wildlife resistant container
 - o Food waste, organics
 - o Organics container, recycling container
- 5. Updates existing definitions to support the wildlife attractant management sections.
 - o Garbage
 - Solid waste container
 - Yard trimmings

Enforcement and Communications

The garbage and organics cart set out times are currently enforced by both the Waste Compliance Officer and Bylaw Enforcement Officers. The Waste Compliance Officer patrols methodically the night before a given collection day to reduce the number of carts at the curb and prevent chance wildlife encounters in the District. Future enforcement efforts will be complemented by a comprehensive communications plan to ensure the community is aware of any changes to the Solid Waste Removal Bylaw.

BACKGROUND:

The proposed Solid Waste Management Bylaw 8436 was brought to the October 5th regular Council meeting, and Council passed a resolution that staff bring back amendments to the existing Solid Waste Removal Bylaw 7631 and Bylaw Notice Enforcement Bylaw 8468 to address black bears and wildlife attractant management. Accordingly, the proposed bylaw amendments presented deal only with the wildlife attractant management issue. It is expected that the proposed new Solid Waste Management Bylaw 8436 will be brought to a Council workshop at a later date.

EXISTING POLICY:

Solid Waste Removal Bylaw 7631, 2007 Bylaw Notice Enforcement Notice 7458, 2004

Metro Vancouver's integrated Solid Waste and Resource Management Plan

ANALYSIS:

There have been considerable operational changes to the District's solid waste collection program since the Solid Waste Removal Bylaw 7631 was last updated in 2007, and District legal staff recommended that the bylaw be repealed and replaced by a new bylaw that reflects the current operation. Also, both Council and staff have received communications from the public via petition(s), email, and other sources seeking higher fines for failure to manage wildlife attractants in response to recent black bear deaths in the community. The proposed bylaw amendments add strong wildlife attractant management requirements and corresponding fines to encourage compliance. It should be noted that the maximum fine amount that a municipality can impose for a bylaw violation is \$500 under the Local Government Bylaw Notice Enforcement Act.

Timing/Approval Process:

The approval of the amendments to the Solid Waste Removal Bylaw and Bylaw Notice Enforcement Bylaw would enable staff to respond in a timely manner to address wildlife attractant issues in the community.

Concurrence:

The amendment bylaws have been developed by Solid Waste staff in collaboration with the Municipal Solicitor, Bylaw Service, and the Clerk's Office. Staff also received input on the wildlife attractant management section from the North Shore Black Bear Society.

Social Policy Implications:

The amendment bylaws seek to prevent human-bear conflicts and other wildlife encounters in the District.

Environmental Impact:

The amendment bylaws seek to support the local black bear population through requiring responsible management of attractant material.

Conclusion:

Approval of the amendment bylaws will support current and future enforcement efforts of the Solid Waste Removal Bylaw.
