SUBJECT: Targeted Official Community Plan Review Action Plan 2021-2030

RECOMMENDATION:

THAT the Targeted Official Community Plan Review Action Plan 2021-2030 is approved.

REASON FOR REPORT:

The following motion was passed at the July 12, 2021, Council Workshop:
THAT the Committee of Council supports the Targeted OCP Review Action Plan
2021-2030 and refers it to a Regular Meeting of Council for consideration.

SUMMARY:

The Targeted Official Community Plan Review Action Plan 2021-2030 (Action Plan) (**Attachment 1**) is intended to move the District towards realizing the 2011 OCP vision and goals in the key topic areas of transportation, housing, economy and employment lands, and climate emergency. The Action Plan includes:

- Eight priority actions;
- 21 supporting actions; and,
- Two implementing lenses (social equity and climate change).

As the topic areas are interrelated, many of the actions address more than one key topic area. These interrelationships are described in each of the priority and supporting actions.

The Action Plan also includes sections on implementation and monitoring (p. 27), and background on the issues, progress to date, and process (Appendix A of the Action Plan). A table of all the actions is summarizes in Appendix B of the Action Plan.

The staff report presented to the Committee of Council at the July 12, 2021, Council Workshop (**Attachment 2**) contains information about the Action Plan planning process, public engagement, and summarizes the priority and supporting actions.

Public Engagement

Over the course of the Targeted OCP Review, opportunities for the public and topic area stakeholders were offered in a diversity of formats. The summaries from each of the public

engagement opportunities were shared with Council during the process, and are available on the District's website, at DNV.org/OCP-review

Based on Council's direction that public engagement opportunities for the Targeted OCP Review should be broad-reaching, and in-depth, a variety of opportunities and ways to share input were provided from August 2019 through to May 2021. The Action Plan describes this process in detail on p. 41 of the Action Plan).

A question was raised at the July 12, 2021, Council Workshop about how many of the respondents to the online survey in spring 2021 are residents of the District. The survey asked respondents for the first three letters of their postal codes. Of 1,262 respondents to this question, 1,215 (96%) replied with a postal code is within or includes the District of North Vancouver. For more information and to see a map of the postal code areas and response rates, see the "What we heard: online survey May 2021" engagement summary available online at *DNV.org/OCP-review*

Should the Action Plan be approved, opportunity for public input would be provided in subsequent work, as appropriate. The Action Plan is a policy guidance document to support OCP implementation. Any resulting bylaw amendments would be brought to Council for consideration at the appropriate time.

Financial Impacts:

Funding to implement the Action Plan would be considered through the long-range financial plan, which is updated annually. For each action, the Action Plan contains a high-level indication of the scale of cost, and if those costs are planned or would be new. Any new funding to implement the Action Plan would be considered by Council through the long-range financial planning process.

Conclusion:

The Targeted Official Community Plan Review Action Plan 2021-2030 is intended to provide a guide for the District towards realizing the 2011 OCP vision and goals in four key topic areas. The Action Plan was reviewed by the Committee of Council, and the Committee directed staff to bring the Action Plan to a Regular Meeting of Council for consideration.

- THAT the Targeted Official Community Plan Review Action Plan 2021-2030 is approved. (Staff recommendation.)
- 2. THAT no further action is taken.
