- Commented on the cost of speed bumps in the District compared with other municipalities;

- Noted that the requested bump out at Evergreen Place and Delbrook Avenue has been approved for construction in 2022; and,
- Commented on speeds on Delbrook Avenue at Donegal Place, noting that one driver was recorded travelling at 78 kilometres per hour within the five minutes he observed speeds on the speed reader board recently provided by the District.

- Spoke regarding traffic calming on collector streets;
- Noted that the Delbrook Community Association and neighbourhood residents have been working on traffic calming; and,
- Advised that a past District Council placed a moratorium on traffic calming on collector roads and requested the moratorium be lifted so that individual projects may be considered on a case-by-case basis.

- Commented regarding pickleball in the District, noting that it is a popular sport, particularly among seniors;
- Advised that other municipalities, including West Vancouver, are removing pickleball courts; and,
- Encouraged the District to keep or increase the number of public pickleball courts.

- Reviewed possible configurations of a replacement bridge.
- Advised that a community shuttle serving outlying areas will be needed; and,
- Commented on the proposed timeline.
